NYCLASS WHEREAS, New York General Municipal Law, Article 5-G, Section 119-o (Section 119-o) empowers municipal corporations [defined in Article 5-G, Section 119-n to include school districts, boards of cooperative educational services, counties, cities, towns and villages, and districts] to enter into, amend, cancel, and terminate agreements for the performance among themselves (or one for the other) of their respective functions, powers, and duties on a cooperative or contract basis; WHEREAS the Plainville Fire District wishes to invest portions of its available investment funds in cooperation with other corporations and/or districts pursuant to the NYCLASS Municipal Cooperation Agreement Amended and Restated as of August 1, 2023; WHEREAS the Plainville Fire District wishes to satisfy the safety and liquidity needs of their funds; Now, therefore, it is hereby resolved as follows: That Kathryn Thomas, Treasurer of Plainville Fire District is hereby authorized to participate in the NYCLASS program under the terms of the NYCLASS Municipal Cooperation Agreement Amended and Restated as of August 1, 2023 AND, the following funds currently deposited in M&T Bank will be moved to NYCLASS: Building Capital Reserve Fund the entirety of the fund; Equipment Capital Reserve Fund the entirety of the entirety of \$200,000;

- 6. 2025 Meet N Greet A motion by Commissioner Rice, second by Commissioner Stachurski to continue the neighborhood events and to purchase a new grill for a cost not to exceed \$600. Motion carried.
